ON 12-11-25, I DEP. JUSTIN SPILLERS WAS DISPATCHED TO 512 SIKES FERRY RD. IN COTTON VALLEY, WITHIN WEBSTER PARISH, FOR A VIOLATION OF PROTECTION ORDER COMPLAINT. UPON MY ARRIVAL, I MADE CONTACT WITH JESSICA SUBLETT, x/x, DOB: x-xx-xx, AND SHE ADVISED ME IN A VERBAL AND WRITTEN STATEMENT:

"AT 1:50PM ON 12-11-25, WILLIAM "BILL" INGERSOLL, CHIEF OF COTTON VALLEY, WHO I HAVE AN ORDER OF PROTECTION AGAINST AS OF 12-1-25, TEXTED MY CELL PHONE WITH A THUMBS UP EMOJI TO A PHOTO FROM HIS CELL PHONE, 318-706-3483.

I CONTACTED THE SHERIFFS DEPARTMENT AS SOON AS I SEEN IT ON MY PHONE.

AS SUBLETT WAS WRITING HER STATEMENT AND TELLING ME THE BACK STORY OF THE SITUATION, DEP. ROBERT DAVIS ARRIVES ON SCENE. AS HE WALKED UP, SUBLETT HANDED ME HER PHONE TO SHOW THE TEXT FROM INGERSOLL. I LOOKED AT THE TEXT AND THE NAME SAVED TO THE NUMBER, 318-706-3483, IN HER PHONE WAS "BILL INGERSOLL COTTON VALLEY POLICE." THERE WERE NO BACK AND FORTH TEXTS ON THE PHONE, JUST A THUMBS UP EMOJI WITH THE PHRASE "TO A PHOTO" NEXT TO IT. AT THAT TIME, DEP. R. DAVIS ASKED TO SEE THE PHONE AND ASKED IF HE COULD LOOK THROUGH IT, AND SUBLETT ADVISED YES, HE COULD GO THROUGH IT AND HANDED IT TO HIM. DEP. DAVIS MANIPULATED THE PHONE TO SHOW DELETED HISTORY, TO WHICH THERE WAS NO RECENTLY DELETED MESSAGES.

I THEN MADE MY WAY TO THE COTTON VALLEY POLICE DEPARTMENT WHERE CHIEF INGERSOLL AND SGT. CHRISTIAN WAS AT. SGT. CHRISTIAN WAS DOING AN INTERVIEW WITH CHIEF INGERSOLL AND GETTING A WRITTEN STATEMENT. WILLIAM INGERSOLL, x/x, DOB: x-xx-xx, WRITTEN STATEMENT:

"I WAS TRYING TO DOWNLOAD A PICTURE THAT JESSICA SUBLETT SENT ME ON A SUSPECT THAT WAS PRETENDING TO BE A SATELLITE SERVICE TECHNICIAN FROM A CALL BACK ON AUG. 4, 2025. I NEEDED IT TO FINISH MY REPORT. I WAS TRYING TO GET THE PICTURE TO COPY AND PRINT, BUT AS I WAS HOLDING IT TO COPY, I HIT A THUMBS UP BY ACCIDENT."

AS INGERSOLL WAS SHOWING US HIS PHONE AND THE MESSAGES, THERE WERE NO RECENT TEXTS ON HIS PHONE FROM HIM TO SUBLETT OR FROM SUBLETT TO HIM.
